
Map Showing the CCD operational Blocks of Gajapati District in Orissa

Activities taken up for NRM and livelihood promotion

Project support by OTELP / ITDA, Paralakhemundi (OTELP P-1 Ext.)

- ☞ 3 nos of tribal ultra poor vulnerable families were supported worth of Rs. 50000/- for grocery, tailoring and motor garage shop at Lung, U.Abasing and Dantada respectively.
- ☞ 75 nos of families have got support of Rs. 10400/- each for goatery unit and locally purchased 2 nos of goats for each household and 01 no of buck for every 8 nos of households i.e., totally purchased 150 goats and 9 nos of bucks. All 150 mother goats and 09 bucks covered under Insurance through national Insurance corporation Ltd.
- ☞ 9 nos of families received support of Rs. 30000/- each for poultry unit and purchased 300 nos of (one month old) chicks, drinker, feeder and medicine from IPDP, Bhubaneswar, Krishna Mother chick unit, Bhadrak and Vet line, Bhadrak.
- ☞ 28 nos of farmers got 1.5 HP pump with support of Rs. 15000/- each and rest of Rs. 2495/- contributed by farmers from Odisha Agro Industries Corporation Ltd. Paralakhemundi
- ☞ 16.8 ha potato (252 qtl) and 4.00 ha Onion (40 Kg) demonstration was held by 32 farmers in Tohojung, Sindiba, Jadasing, Rungrungba and Bureising villages. Each farmers got Rs. 3750/- per ha incentive for Potato and Rs. 3300/- per ha incentive for Onion.

- ☞ 42 nos of water filters and 14 nos of smokeless Chula provided to the poorest of the poor families identified including malnourished children and mother.
- ☞ 9 nos of farmers were supported 500 nos of Mango saplings (Dasheri variety) for 5 ha. Plantation under WADI in Bontilida village of Ajayagada GP, and 2nd year maintenance in 20 ha WADI in Sindiba, Bureising and Maneba village of Gumma Block with convergence support of MGNREGA and direct support from SCA to TSP from of ITDA / OTELP
- ☞ One Farm pond, Field bunding in 2 Ha, 140 nos of Gully plugs, Stragarrd Contour Trench in 3 Ha and Stone bunding in 10 Ha has been developed for soil & water conservation measures. Total 16097 humandays generated for the programmes and Rs. 32,37,158/- mobilized under MGNREGS for both plantation and NRM activities.

Project support by OTELP / ITDA, Paralakhemundi (OTELP Plus)

- ☞ 5 hectors of Mango plantation has been taken up in Baijhal village & 25.2Ha, in 2nd & 3rd year maintenance was made in village Bhubani, Ameising, Brusava, Badudi and Tarbaul under WADI through MGNREGA where 6954 nos of humandays were created for 6 villages amounting Rs. 12,09,996/-.
- ☞ 6003 no's of man days are created in 8nos of villages through convergence on NRM activities i.e., SCT in 2 ha, 20 nos of Gully Plugging, Stone bunding in 2 ha, and land levelling in 3 ha. and Rs. 23,35,516/- mobilized under MGNREGS for both plantation and NRM activities.
- ☞ Digging of 5nos of well for WADI field irrigation in 3 villages namely Jurubudi, Papada and Amesing costing Rs. 6,25,000/-.
- ☞ 24 nos. of Beneficiaries of 3 villages were supported for onion cultivation and 28nos. Of beneficiaries were supported for Potato cultivation in Rabi season and 128

beneficiaries of 8 villages were supported for onion cultivation in kharif season. The average yield of onion was 3qtl. Per beneficiary.

- ☞ 30 nos of beneficiaries of Bhubani and Tuburda village were supported for 6 Ha. ginger cultivation and 104 beneficiaries of Bhubani, Tarbaul, Tarjasing and Ruising villages were supported for 20.825 Ha. turmeric cultivation. The cultivation is under progress.
- ☞ 5nos of small lift irrigation projects were constructed under BK"O"GY in Baijhal, Ariada, Tarbaul, Tarjasing, Tamegarjang village to irrigate 78 Acre of land and people are able to cultivate vegetables as well as their primary crops.
- ☞ One Diversion Based Irrigation project was constructed at Amesing village of Masiki VDA. 29 no's of farmers were benefitted & able to cultivate 2nd crop in 23 acres of land.
- ☞ 100 nos. of goats, 7nos of Buck, Feed and Medicine procured by the VDC & insured the small ruminants for poorest of the poor people in 22 villages of OTELP Plus operational area to enhance their economic standard.
- ☞ In 8 nos. of poultry units procured 300 nos of chicks, 6 nos Drinker and 6 nos of feeder by the VDC for each units for poorest of the poor people in villages of OTELP Plus operational area to enhance their economic standard.
- ☞ 40 nos. of pump sets were supplied under IFAD Top Up Assistance and 44 no's of Pump sets has been supplied through convergence with ITDA, Paralakhemundi to 84 beneficiaries for water lifting during water stress period and winnowing purposes.
- ☞ 4 no's of unemployed skilled youths in 4 villages has supported under IFAD Top Up Assistance for economic activities i.e. Tailoring & Carpentry Rs.45000/- each.
- ☞ 2 no's of ultra poor people were supported for grocery shop & Carpentry under IFAD TOP UP Assistance for their economic rehabilitation Rs. 50000/- each.
- ☞ In Badudi village one of vulnerable family had support for low cost housing materials under IFAD TOP Up Assistance.
- ☞ Individual water filter have been supplied to 42 no's of beneficiary in Bhubuni village under IFAD Top up Assistance to get safe drinking water to the family.

Project support by MISEREOR / KZE

- ☞ 27 village Development Committee have been formed during the reporting period. Both men and women are included in the VDCs.
- ☞ Project team members participated in the village level meeting and sensitized the people on Govt. poverty alleviation, food and social security programme and insurance programme of govt. like Pradhanamantri Suraksha Bima Yojana, Pradhanamantri Jivanjyoti Bima Yojana, Atal Pension Yojana and Sukanya Yojana.
- ☞ 110 farmers in 32 villages have adopted line transplantation in 86.95 acres of land.
- ☞ 11 farmers have adopted SRI in 8.32 acres. There is an increase in the yield in line transplantation and SRI
- ☞ 57 farmers have collected and stored quality seeds for next year.
- ☞ 57 farmers have taken up vegetable cultivation in 51.70 acres of land
- ☞ 223 farmers have prepared organic manure and pesticides like Amrutajala, jeebamruto, Handikhata, Pranamruta, Hadari and used in their paddy and vegetable field.
- ☞ 11 animal health cum vaccinations camps were organized in collaboration with veterinary department where 1658 domestic animals have been vaccinated. The community has paid the fees. There is a decrease in the mortality of livestock.
- ☞ 7 youths participated in the 21 days tailoring training programme organized by Rural Self Employment Training Institute with the facilitation of project staff. Two of them have already started team support work at their village.
- ☞ Livelihood support of Rs. 100000/- provided to 10 members (Rs. 10000/- each) for income generation.

- ☞ 28 NOS Kerosene pump supplied to Farmers on Convergence form ITDA for round the year vegetable Cultivation.
- ☞ Identified 178 Beneficiaries in 13 Villages for Mango (90 Ha.) and Litchi (25 Ha.) plantation in 115 ha. in 10 GPs of Mohona, R.Udayagiri and Rayagada Block under MGNREGS.
- ☞ Detailed Project Report prepared for 3 Nos. of Activities for 53 beneficiaries in 2 GPs of Gumma and Mohona Block which is yet to approval by ITDA.

Convergence programmes for livelihood enhancement

- ☞ 100 qtl of Turmeric for 25 farmers in Ragidi VDC in 5.00 ha and 112.80 qtl of Ginger seed for 37 farmers in Bureising village of Tumulo GP 7.5 ha supported by ITDA through SCA to TSP.
- ☞ 1500 nos of Papaya saplings distributed to 22 farmers in 6 acres in Sindiba & Bureising village of Tumulo GP supported by Horticulture department.
- ☞ One bio-gas plant was installed at Anganawadi Centre of Tohojung village supported by CTxGREEN – a Canada based research agency.
- ☞ One Cashew apple juice extraction plant was established at Tohojung village for bio-fuel supported by CTxGREEN – a Canada based research agency.
- ☞ 3 acres of Lemon grass plantation was done in Lung village with support of Horticulture department.

- ☞ Stone bunding in 10 ha, Staggered Contour Trench in 4 Ha, 5 nos of Gully control structure, 4 nos of gully plugging, One Farm Pond, Field bunding in 2 ha. Worked out under MGNREGA.
- ☞ 30 nos farmers of Tumulo, Sindiba & Rungrungba villages in OTELP P-1 ext areas have cultivated Sunflower in 30 Acres supported by Agriculture dept.
- ☞ 9 nos of farmers have supported 5 ha. Mango Plantation (Dasher variety) under WADI with convergence support of MGNREGA and SCA to TSP with support of ITDA / OTELP in Bontilida village of Ajayagada GP, Gumma Block.
- ☞ RKVY programme under Improved Pigeonpea production Technology (IPPT) was demonstrated in Bontilida, Badakalakote, Kitumba and Sarubuda of Gumma Block in OTELP P-1 extension areas in 43.5 acres. Total 348 Kgs of seed (ICPL 14001, ICP 4035 variety) was provided to 124 farmers including 90 male farmer and 34 female farmers.
- ☞ Rubber plantation with support of ITDA was implemented in U.Abasing village of Gumma Block in 25 ha of land for 65 farmers in OTELP P-1 ext area.
- ☞ 198 beneficiaries have mobilized quality paddy seeds in facilitation of farmers club from agriculture department and line transplantation has been done in 247 Acre in 14 villages of Serongo, Bhubani and Baijhal GPs of OTELP Plus Areas.
- ☞ Convergence with OLM, ITDA, Horticulture Mission, Agriculture & Veterinary Department etc and mobilization of resources.
- ☞ Skill development of Youths

- ☞ 473 VDC and Village meeting was held in programme outreach area. The community members, VDC members, SHG members have present. Emphasis was laid on preparation of Annual Work plan Budget, smooth implementation of all developmental work, selection of vulnerable beneficiaries for enterprise promotion, livelihood activities to enhance their income potential through agriculture activities, livestock and MGNREGS.

Major Achievements

- ☞ The economic units supported to ultra poor vulnerable and physically challenged persons are maintaining the business successfully at OTELP P-1 areas of Gumma Block and got Rs. 3000/- to Rs. 8000/- (Average) per month from tailoring, carpentry, motor garage and grocery units.
- ☞ With the support of RKVY, the farmers have got Rs. 30000/- to Rs. 80000/- (Average) especially from Brinjal, Turmeric, Onion and Tomato in one cycle seasonally in Tohojung village of OTELP P-1 areas.
- ☞ The SHG members and farmers have got actual market price of Tamarind, Cashew, Jackfruit and Mahua through collective marketing without intervention of any middlemen in Sindiba Cluster of OTELP P-1 areas.
- ☞ Vegetable cultivation with organic practices is encouraging the women farmers for good yield and good profit. They are selling themselves in local market without depending any middlemen for transportation, price fixing and marketing.
- ☞ Community are demanding and placing their demands in palli sabha and gram sabha for infrastructure development and livelihood promotion through different line departments under MGNREGA and also resource mobilization like improved vegetable seed, certified paddy seed, fruit bearing trees etc.
- ☞ The community of 4 villages namely U.Abasing of Munising GP, Bontilida & Kantisahi if Ajayagada GP and Bongodising of B.Kalakote GP of Gumma Block are now free from drudgery from fetching water from streams and all households are getting drinking water at their door step throughout the year which was established with support of ITDA / OTELP / DIF.
- ☞ 118 Mother goats are provided to 59 beneficiaries in Nila, Balingda and Shanti watershed areas of Gumma Block. Out of this, 37 mother goats have birth to 37 kids which is good profit for the beneficiaries.
- ☞ 6 nos of Mango producers group has been formed for management of WADI Plantation in 6 villages.
- ☞ 8 no's of Water user groups has been formed for of post project management of Irrigation projects.
- ☞ CSPs have facilitated 7 no's of old age pension, construction of 1225 individual toilets under Swachh Bharat Abhiyan in 27 villages, 110 no's job card, open 107 no's of Bank Account for MGNREGS work and correction of 73 no's of Aadhaar cards.

Important visitors to the field area

- ☞ Mr. Deepak Mohanty, Livelihood expert from PSU, OTELP, Bhubaneswar visited Jangjanglo village of OTELP P-1 area of Gumma block along with Finance officer and micro finance officer and met with the goat beneficiaries. Interacted with them regarding care and maintenance of mother goats and buck.

- ☞ A team of 60 members from Malkangiri OTELP plus of WASSEN, Chitrokonda have visited Tohojung, U.Abasing and Munising of Gumma Block OTELP Phase 1 areas on 14-10-2015. They have visited Drip irrigation with trailles, mother chick unit, night shelters, Turmeric processing unit, carpentry unit, rubber plantation, rubber extraction process, vegetable cultivation and gravity flow based drinking water unit. The VDC members, CCD – OTELP staff and ITDA SMS have facilitated for the exposure team. The y commented that they have learnt new things for replication.
- ☞ A team of 11 members from FARR organization, Muniguda, Kalahandi District had an exposure to U.Abasing and Tohojung village of OTELP P-1 areas of Gumma Block. They have interacted with James Luara of Abasing regarding his initiation on carpentry unit supported under IFAD and also visited flour mill, drinking water project, MCU and night shelters. They have felt happy to see the initiatives of drinking water project through gravity flow. They have also visited Tohojung to see the MCU, night shelters, Traillies work and cashew apple processing unit.
- ☞ A team of 40 members from Reals, Tekkali, Andhra Pradesh visited Sindiba on 23-03-16 to see the different activities by SHG members. 25 members from Saraswati SHG and JRSM PWD SHG invited the exposure team members and discussed on present activities like vegetable cultivation, Tamarind processing, maintenance of transport vehicles like Tracker, one Bus supported by ITDA, 3 members of JRSM Disable SHG namely Carpentry unit by Gangebo Mandal, Tailoring unit by Jabari Bhuyan, Grocery Shop by Pabitra Bhuyan and other seasonal business. The exposure members learned a lot and proud for the initiatives made by Saraswati SHG and JRSM Disable SHG.

☞ CDVO, Gajapati along with Micro Finance officer, OTELP have visited the field of Sindising and Dantada to see to Goat sheds and poultry units established by vulnerable families supported under IFAD top up assistance through ITDA / OTELP. CDVO visited to have an feasibility study for suitability to fit for the goat rearing.



CASE STUDY -1

Vegetable vending

With the support of pumpset by OTELP / ITDA / IFAD, Mr. Adia Bhuyan of Maneba village of Tumulo GP of Gumma Block has taken off season vegetable like Cauliflower, Brinjal, Tomato, ladiesfinger, Beans and other products like Turmeric and Onion. In the last 8 months he got total income of Rs. 22,700/- by selling the products in serongo local market.



CASE STUDY -2

GODS GIFT...

Baijhal village is one of the remote and hilly villages of Gumma blocks of Gajapati district having 200 HH. All the HHs is comes under ST families. Tipano Raita is having skill of motor repairing. But due to lack of money, he was not able to open a motor garage. He has two daughters and two sons and having two acres of land which is infertile. He could not maintain his family so he went to Gunupur which is 20 kilometers far from the village to work in a cycle mart to learn cycle repairing. After that without any infrastructure



he started a cycle mart with his own effort, earning Rs 50/-to 100/-per day. Lack of proper infrastructure and instruments, his income was very low and he was facing lot of problems to maintain his family.

Keeping this in mind during preparation of VDLP the name was proposed to provide motor garage to open in the Udasing junction. When the proposal of IFAD TOP UP assistance sanctioned the VDA proposed the name as Tipano Raita S/o Mandi Raita to open a motor garage at Udasing junction.

Now he is earning Rs. 12000/- (Average) per month. Out of the profit he was able to meet his daughter's marriage expenditure, near about Rs. 80,000/-. At present he is living in very pleasant and healthy life.

CASE STUDY -3

Susila Badamundi is a tribal women farmer of Mangarajpur Village. She has been actively involved in agricultural work with her husband. But she has never got an opportunity to enhance her knowledge and skill on agriculture. Her family was adopting traditional method of paddy cultivation and getting less production i.e. 600 kgs of paddy from their 1.25 acre of land.



During the profiling of women farmers, the project team identified her as one of potential and progressive women farmer. She participated in the training programmes organized by CCD on line transplantation and System of Rice Intensification methods, organic way of cultivation etc. Then she convinced her family members to go for line transplantation Instead of traditional method of farming and use of organic manure in place of chemical fertilizers.

During this rainy season, she has cultivated paddy in 1.25 acres of land and adopted line transplantation method and used organic manure (Jeebamruta and Hadari) in the paddy field. She followed all the principle like timely weeding & application of manure. She also selected a patch for seed collection purpose. The growth of the paddy was good, tillering was excellent (double than the other farmers). Even though there is very less rain during fruiting, She managed to get the yield of 1200 kgs paddy from her 1.25 acre of land. She also kept quality seeds for the next year. Other farmers of the village visited her field and appreciated their effort. She has also taken up vegetable cultivation.

Susial is very much encouraged now and she will continue adopting the organic farming next year also. She thanked the project staff for their guidance and support during the cultivation work. The project team members are keeping regular touch with her and she will be one of the master farmer in the locality.

The programme started in Feb 2012 with the financial support of SDTT- Tata Trust and technical support of MITRA, Christian Hospital Bissam Cuttack. CCD and other five NGOs (PRAVA, JKP, SURAKSHA, CARD & SACAL) collectively through a Consortium intervened in the endemic zones (300 Villages) in 6 blocks of Gajapati District. CCD was leading and coordinating the programme. This programme came to an end in September 2015.

Activities taken for Health and Nutrition promotion

- ☞ Capacity building of Project staff, pregnant women and lactating Mothers on Malaria and Malnutrition
- ☞ Training of the MIS personnel was held on end line survey entry and analysis.
- ☞ End line survey undertaken in 20% sample villages, analysis of end line survey and comparison with base line survey.
- ☞ 28 Malaria – Malnutrition camps were conducted during this reporting period. 575 children were screened in the camps. 29 positive cases were identified and treated.
- ☞ 1038 Fever cases are reported during the reporting period out of which 530 are male and 508 are female.
- ☞ 339 malaria cases were identified and all the cases are treated. 296 cases were treated by VHVs/MRPs.

Major Achievements

- ☞ The programme was able to reduce malaria parasitemia among the children by 67%. Every year active screening and treatment camps (Malaria and malnutrition Camps) were conducted during malaria endemic period (June-15 to November-15). Around 90% of eligible children were tested. In the year 2012 the point prevalence among the children was 16. It has reduced to 5 in the year 2015. Around 67% of reduction in the prevalence of malaria was noticed in 50 villages.
- ☞ There is also improvement in the nutritional status of the children. The percentage of severely underweight children has decreased from 23 % in 2012 to 15% in 2015
- ☞ The use of LLIN and community bed nets is far better now. Due to rise in the temperature in the month of May'15, June'15 and July'15, community could not properly use the mosquito nets due to humidity. But the women and children have used the nets and have been less affected by malaria.
- ☞ The use of neem and karanj oil has also been adopted by community as a repellent. It was also traditionally practiced and it was revived.

- ☞ Making smoke of neem leaf, turmeric, dates seeds etc have also been tried and adopted by community.
- ☞ Observation of weekly dry day at the village level has also been adopted and are being observed in villages. This is helping in reducing the breeding sites.
- ☞ VHV/MRPs have provided early diagnosis and treatment services at door steps. ASHA has also provided services to community. All the malaria cases were treated.
- ☞ Preference for blood test in case of fever has been increased. It was more than 90% during last two years. The project was able to reduce the burden of malaria among the community with the active involvement of the community.
- ☞ Understanding on malnutrition among the community has increased, More than 70 percent of the mothers can tell about the weight of their children and it is increasing or decreasing. The participation of parents in the VHND, and the referral cases have increased. The parents are taking their children to PustikarDiwas with ASHA and taking to CHC/PHC for health check-up.
- ☞ The performance and confidence of ASHAs has been increased with this programme. Their knowledge and skills on RDT and malaria treatment was enhanced by VHV/MRPs.

WOMEN EMPOWERMENT & MICRO ENTERPRISES PROMOTION

Since inception CCD has been emphasizing on Women Empowerment to mainstream gender equity. This is the priority area at this hour to bring the women to a common platform with a view to prove themselves for self reliant and get their legitimate rights. CCD has mobilized ST, SC and the marginalized women into Self Help Groups, Federations and Cooperative societies. Two cooperative societies (Gajapati Women Cooperative Societies Ltd, Paralakhemunid and Mahendragiri Cooperative Societies Ltd, Gajapati) are now running independently with active cooperation and participation of women in decision making process and every development process. During this year with the Support of State Bank of India and other project support, CCD has provided micro-credit support to self help Groups and also individual women for promoting microenterprise and financial inclusion.

- ☞ Loan amount of Rs 1,14,000/- has been given to 8 members of Rayagada Block for undertaking income generation programme from the Cooperative.
- ☞ Members have repaid Rs 3,95,211(principal) and 58,564 (interest) of the previous loan during the reporting period. Amount of Rs 14, 89,228 (cumulative loan amount) is outstanding with 132 members.
- ☞ Savings of Rupees 5,60,090 has been raised from members of Rayagada Block.
- ☞ Women federation meeting was organised at B.Kolakote of Shanti and Emani watershed areas along with B.Kolakote panchayat federation members. 74 women SHG members participated from 11 SHGs with OTELP support.
- ☞ Strengthening Mahendragiri Women Cooperative Society of Rayagada Block.
- ☞ Mapping of SHGs, formation of new SHGs and linkage with OLM and other resource agencies in Rayagada Block
- ☞ 10 SHGs federations were formed in Gumma block - OTELP Plus areas and accounts were opened at concerned service area banks and nurtured regularly.
- ☞ 81 existing SHGs were functioning in facilitation of CSPs for regular meetings, savings, loan instalment collection and preparation of business development plan in OTELP Plus areas of Gumma Block.

Major Achievements

- ☞ With regular orientation and training to SHG and Federation members, now they have increased the monthly saving from Rs. 50/- to Rs. 100/- and regular savings, book keeping and internal lending is continuing among the SHG members.
- ☞ The women federation members merged with GP level federation and mobilizing support from OLM.
- ☞ With the support of project staff and cooperative staff, four self-help groups have undertaken. Pineapple juice extraction and supply 2500 kgs of juice to Odisha Milk Federation Corporation. The primary producer got good price of the pineapple. 32 women members got employment and profit out of this value addition work.
- ☞ 111 SHGs are functioning in 46 villages. 911 women members have been covered in the SHGs in Rayagada block.
- ☞ 58 SHGs have been linked with Odisha Livelihood Mission and 42 SHGs have got revolving fund support of Rs 7,45,000, 00 from OLM in Gumma and Rayagada Block.
- ☞ 8 SHGs have got loan of Rs 50,000/- each from Odisha Livelihood Mission and three SHGs have applied for loan.
- ☞ 41 SHGs of Gumma and Rayagada Block actively involved and continuing collective marketing of Tamarind and jackfruit.
- ☞ 65 SHGs have provided Rs. 15.75 lacks as seed money for different income generation activities in OTELP p-1 extension areas of Gumma Block.

CASE STUDY - 1

Tamarind vending by SHGs

The SHGs of Sindiba, Talaul, Ragidi and Jirry villages have successfully marketed Tamarind collectively. 4 nos of SHGs namely Saraswati SHG, Archana Shakti Dal, Swashakti Dal and Sunem SHGs respectively have leased 94 nos of trees from villagers by paying Rs. 81000/- to them. Now the SHG members have collected 8900 kgs of Tamarind and sold @ Rs. 25/- per kg in Paralakhemundi market. They have got Rs. 2,22,500.00 as gross profit and got Rs. 1,84,500/- net profit. Now they have free from sahlukars / middlemen's exploitation. Similarly out of total 62 HHs of S.Kalakote village of

B.Kalakote GP, 25 HHs are collectively procured 83 qtl Tamarind at one point and marketed at Paralakhemundi by a truck load @ Rs. 25/- per kg and got Rs. 2,07,500/- as gross profit. The net profit is 1,82,500.00. This is a good change among the community for several orientation for collective marketing by OTELP / CCD.

- ☞ 6 SHGs of PwDs have started phenyl trade, agarbati making and seasonal business.
- ☞ 19 new SHGs of PwDs have been formed during the reporting period. 22 existing defunct SHGs of PwDs have been regularized.
- ☞ 116 PwDs have started different income generation activities like Mobile repairing shop, grocery, tailoring, leafplate making, agarbati, phenol making, goat rearing etc with the facilitation of project staff
- ☞ 11 SHGs of PwDs have got revolving fund support from OLM and Mission Khyamata.

- ☞ A musical group (consisting of 15 PwD members) have been formed under the leadership of Nursingh NathPadhi (Visually Impaired person). The group has performed at Gurandi on the eve of Ganesh Puja.
- ☞ Hon'ble MLA, Paralakhemundi was invited to SAMARTH and discussion held with him regarding the problems faced by PwDs in their day to day life.
- ☞ Mr.Prafulla Kumar Mohapatra, Secretary SAMARTH has been awarded on 3rd December on the eve of World Disabled Day for his outstanding contribution in the field of disability.
- ☞ The construction of Braille Resource Centre has been started with the support of ITDA. The centre will be helpful for the blind children.
- ☞ ITDA has procured braille learning materials like Braille Printer, Mount Batten, Eye ball-scanner, Text Reader, Focus Braille Key Board, Daisy Player, Talking Calculator etc for the Braille Resource Centre of SAMARTH.
- ☞ The issues of Inclusion of PwDs in National Food Security Act have been raised at several forums. A list of 57 nos of PwDs has been given to Civil Supply Officer who have not covered under NFSA. Civil Supply Officer has sent the list to concern Block Development Officers for necessary action.
- ☞ A memorandum has been given to collector on 3rd December 2015 on 3 % reservation in Govt. jobs and all poverty alleviation programme.
- ☞ Four block level DPOs have been promoted. Block level leaders have placed their demands before the BDOs through a memorandum.


