

<u>Livelihood promotion through Sustainable Agriculture Practices</u>

CCD has been focusing on transition of traditional agriculture practices to sustainable agriculture practices promoting Organic Farming and climate smart agriculture. The operational areas are coming under rainfed, sloppy, hill ranges, small land holdings and low production causes food and nutrition insecurity. To ensure food and nutrition security for the tribal farmers, CCD has intervened to educate the tribal farmers on sustainable agriculture practices, soil & water conservation measures, less water consumption seeds, short duration crops and truber crops / climate resilient crops.

1260 farmers have adopted organic farming in Paddy, Ragi, Vegetables and Fruits with agronomic practices in 1008 ha. Practice of regular consumption nutritious food has been increased.





Promotion of Millets in Tribal Areas

CCD has been implementing Odisha Millets Mission in Gumma Block of Gajapati District reviving the traditional cultivation of Ragi and other minor Millets and focusing on sustainable agriculture practices with organic inputs.


Awareness campaigns in 17 Gram panchayats of Gumma Block to encourage the tribal community for Millet promotion with agronomic practices and increase household consumption especially among children, lactating and adolescents. Due to Organic, the yield is increasing with more nutrition value which is encouraging the tribal farmers for daily consumption with value added foods prepared by Ragi and other Minor Millets and selling the surplus at mandi with MSP of Government.

Awareness campaigns has impacted the community / SHG members in preparing value added items from Ragi and other Minor Millets and feeding their Children. Practice of regular consumption of Ragi / Millets has been revived among the tribal community.







ANNUAL REPORT - 2021-22

Organic Vegetable Cultivation

CCD has been emphasizing on Nutrition Security of the tribal families especially Pregnant, lactating mother, adolescent and Children under 6 years. Orientations and Sensitization programs has been conducted for preparation and usage of Organic Compost, Organic manure and pesticides in Paddy, Ragi and Vegetable Cultivation.

During the year 763 tribal farmers have cultivated Cabbage, Cauliflower, Tomato, Broccoli, Beans, Radish, Brinjal, Okra, Chilli, Ridge Guard and Green leaves in 92 ha. using organic inputs. The yield of vegetables has come upto 460 qtl. They have kept 60% for consumption and rest 40% was sold in local market and got Rs. 14,00,000/- (Average). The additional household income was approx. 2000/-.





CCD has initiated Bucket kit Drip irrigation system with the support of KKS-BMZ to ensure micro irrigation during summer season for vegetable cultivation to enhance the nutrition status as well as annual income source. Soil & Water conservation measures have been promoted.

- ⇒ Farm / Earthen bunds has been constructed by 108 smallholder farmers in 22 ha.
- ⇒ 8.15 ha. Fallow / wasteland land was converted to cultivated land by 41 smallholder farmers.
- ⇒ Compost pits was constructed by 209 tribal households for preparation of organic compost.











Small farmers are collecting Nutritious vegetables from their Home / Backyard Kitchen Garden for daily consumption and sale in the local market.

Farmers Producers' Company (FPO)

CCD has promoted Ujayalla Farmers' Producers Company in Gumma Block consisting of 295 tribal farmers with support of Odisha Millets Mission. During this year the FPO has procured 2754.12 qtl Ragi from 645 tribal farmers and sold at Mandi Point with MSP of Rs. 3377/- per qtl. Total Amount of Rs.

93,00,663.24 and the FPO has earned 10% of margin commission of Rs. 93,006. The income source of the farmers has increased and middlemen dominancy and dependance was reduced.

The FPO has exhibited different value added products of Ragi & Minor Millets in Pallishree Mela - District level Food Festival organized by District Administration,

Gajapati. The value added products like Kangu Kheer,

Kangu Biriyani, Ragi Biscuit,

Ragi Bread, Ragi Ladu,

Ragi Upma, Ragi Idli, Mixtures & Cakes of Ragi has been

prepared by FPO.





Activities through Convergence - Resource Mobiliation from Integrated Tribal Development Agency (ITDA), Gajapati, Government of Odisha - Under Mission Jeevika

- 17900 Mango Saplings and fertilizers were supported to 575 Farmers of Gumma, Rayagada, R.Udayagiri, Nuagada & Mohona Blocks of Gajapati under Mission Jeevika and transplanted in 178.80 ha through MGNREGA. 29328 humandays generated and the farmers have received Rs. 61,10,420.00 @ Rs. 215/- per day.
- 27800 Cashew saplings were provided to 871 Farmers in Gumma, Rayagada, R.Udayagiri, Mohona & Nuagada Blocks and transplanted in 170.32 ha. 27288 humandays generated and the farmers received Rs. 58,66,920/- @ Rs. 215/- per day under MGNREGA.
- 1137 farmers in Gumma, R.Udayagiri, Mohona & Nuagada Blocks were supported 160650 Rubber saplings and transplanted in 321.24 ha. 14640 humandays generated and the Farmers have received Rs. 31,47,600/- under MGNREGA.
- 11070 Poultry Birds with Iron cage, Drinker, Feeder provided to 1107 landless farmers in Gumma, R.Udayagiri, Nuagada & Mohona Blocks of Gajapati under Mission Jeevika. Rs. 5000/- earned as an average by the families by selling of eggs and chicks during the reporting period.
- 407 small farmers have cultivated Cabbage & Cauliflower in 152 acres with input support of Rs. 4,76,700/-. During the period 790 qtl yield has come up and after keeping for consumption, the surplus has been sold in local market and got Rs. 15,46,000/-.
- Sugar free Rice with fertilizer has been provided to 200 farmers in Gumma & R.Udayagiri Blocks of Gajapati District for 100 Acres. The harvest has come upto 1100 qtl and Got Rs. 13,60,000/-.
- 8302 HHs have participated under MGNREGA in Gumma, R.Udayagiri & Mohona Blocks for soil & water conservation works in 200 acres. 233136 humandays generated and they have received Rs. 6.63,78,240/-.
- 60 nos of soak pits mobilized by the households of Kurlandaguda Village under Tarangada GP, Gumma Block from DRDA, Gajapati under Swatch Bharat Mission.

WOMEN EMPOWERMENT & MICRO ENTERPRISE PROMOTION

CCD is always focusing on Socio-Economic-Politico Development of Women encouraging their active participation in Agriculture, Livelihood and Decision making process. Till now CCD has promoted 749 Women SHGs, Two Women Cooperatives and Five Women Producers Groups in Gajapati District. The Cooperatives are providing easy credit services to its members to improve their income generation activities. SHGs are also providing credit support to their members through internal lending for Health, Education and Income generation.

- ◆ 139 women SHG members have mobilized Rs. 38,20,000/- from Panchayat level Federation promoted by Odisha Livelihood Mission (OLM) and Mission Shakti.
- Sudipta Women SHG of Badakalakote Village of Gumma Block has established a Tiffin Centre
 preparing and selling the Millet Value Added items supported by Mission Shakti and creating
 good awareness for consumption of nutritious food for all.
- 272 women SHG members from R.Udayagiri and Mohona blocks have promoted group business in Pisciculture mobilizing Rs. 12,96,000/- from Government under Mission Jeevika. 23 qtl fish collected and sold in Rs. 3,70,000/-.
- ◆ 13 women SHGs were provided Agri-implements with the support of KKS-BMZ for income generation by supplying to the needy farmers on hiring basis.
- Bikash Women SHG of Kurlandaguda village of Gumma Block has mobilized support for Pisciculture from District Fishery Department, Gajapati and started their group business by leasing the pond of 5 acres. The women SHGs are happy to earn ensured income from fish business.

CASE STUDY

Radha Mandal of Mandalsahi Village in Rayagada Block, Gajapati is a marginal farmer was maintaining 4 members family with difficulties because of low income. She is having 1 acres of low land and 0.50 acres of Medium land (Padar). Due to finance constraints, she has kept idle of 1 acres of low land and only cultivating vegetables in some part of Medium land. Her husband is a daily labour. The average annual income was INR 6000.

Radha has joined as a shareholder in Mahendragiri Women Cooperative. She has opened a savings account at the cooperative and with recommendation of the board and loan committee, she was supported INR 20,000 credit.

She has started her own vegetable shop and other commodities. Now her average annual income is increased upto INR 20,000. Now she is happy with the initiatives of CCD and Cooperative. The family living style is changed, children are now reading Intermediate standard and the family members are consuming nutrition food regularly. She has started cultivation Paddy and Ragi in low land and also different vegetables in 0.50 acres of Medium land with organic inputs. She has also rearing 10 chicks and 5 goats and selling in market.



MAINSTREAMING OF PERSONS WITH DISABILITES

CCD is working with 3015 Persons with Disabilities in Gajapati District and strengthening the District level People's Organization of Persons with Disabilities - SAMARTH and also the Block level Peoples Organizations of Persons with Disabilities to enable them to access their Rights and Entitlements as well as ensure their active participation.

Regular monitoring and review is being conducted by SAMARTH through monthly intergroup network meeting at District and Block level to review the progress of socioeconomic development of PwD members and also encouraging the PwD members to mobilize support services from Government through Advocacy approaches.

- CCD has been emphasizing on socioeconomic development of Persons with Disabilities and Vulnerable Sections of the Community providing support for their income generation and micro enterprise promotional ensuring sustainable income sources.
- 21 vulnerable / PwD families were provided 4 5 breeding goats each to enhance their livelihood and annual income potential supported by KKS-BMZ, Germany. One training was conducted for care & management of Goats.
- 20 Persons with Disability (PwD) members were provided Rs. 2,00,000/- (Rs. 10,000/- each) to revive their micro enterprises under Self help projects supported by REHASWISS, Switzerland.
- 27 PwD members were provided Rs. 2,65,000/- from the revolving fund of SAMARTH to strengthen their existing income generation activities.
- During COVID pandemic the income generation activities of the PwD members were dislocated. To revive their income generation activities REHASWISS has extended relief support to 60 PwD members for Rs. 2,83,800/- (Rs. 4,730/- each) to boost their self confidence.



CASE STUDY

Radhika Sabar is the resident of Raigumma Village, Rayagada Block of Gajapati living with her husband who is a physically challanged person. Her husband was running a cycle repair shop at Mandalsahi village which is 10 Km distance from our village. With low income they were managing two members family facing diffuclties. But due to distance daily to and fro was the hinderences and it was forced to close the cycle shop.



Radhika has started earning by daily labour and chick rearing which was also not sufficient to meet the regular needs. Radhika got the support of INR 10,000 from Mahendragiri Women Cooperative and started chick farm. Now she has 41 chicks out of them 15 are local variety and 26 are hybrid. She started business of egg from local verity chicks and hybrid variety are used for selling. One hybrid chick is selling in avarage INR 400. The agerage annual income is increased to INR 30,000 in compering to last two years. They are happy now and Radhika is blessed with a daughter who is 2 months old. She is able to take care of her husband and daughter.

SAMARTH is a District level Disabled Peoples' Organization promoted by CCD is working for the empowerment of Persons with Disabilities encouraging their participation and facilitating to access their Rights & Entitlements through Advocacy. SAMARTH is establishing good rapport with Government Departments and DPO Networks at District to International level.

- Three Intermediate Students with Visual Impaired have received One Android Mobile each from Collector cum District Magistrate, Gajapati sponsored by Dy. Executive Officer, ORMAS, Nawarangpur District, Odisha.
- Five Persons with Disabilities have received Marriage Incentives. Four members received from District Judge of Rs. 2,50,000/- each and One member received from Collector cum District Magistrate of Rs. 50,000/-.
- Three Intermediate Students with Visual Impaired have received study scholarship of Rs. 2000/-each from Odisha Blind Foundation.
- Three Persons with Physical Impairment and Two Visual Impaired Persons have participated in Jhoom India Jhoom Talent Program and received Certificates from Shantidham Foundation.
- Four Persons with Disabilities have received Certificates from Nehru Yuba Kendra, Gajapati participating in District Cultural Meet.
- Three Persons with Disability members from three self help groups participated in Pallishree Mela organized by District Administration. One stall was installed and the members have exhibited their own products like Agarabati, Broom and stitched dress materials.



Our Two Physiotherapist are providing regular services visiting 3 - 4 times in a month at the door step of the Children and also trained the parents on Therapy techniques so that they can boost their Children with need based exercises.

CASE STUDY

Kasab Bhuyan, aged about 07yr is only son of Hare Krushna Bhuyan of Anlabara Village, Rayagada Block. The symptom of cerebral palsy was observed at the age of 2 yr and he can't walk and stand properly. His parents made his treatment in government and private hospital. But could not recovered.

He was identified by CCD with the project support of SSEPD, continued physiotherapy exercises 4 times in a month by our physiotherapists with the equipments like walker, smile ball, accupressure ball U/S and IFT. The parents were also being oriented on the techniques of exercises. The parents have continued daily exercises two times a day. Gradually Kesab has started walking with support of wall, walker and his parents. Now he is reading in 1st standard.


