



MAJOR INPUTS AND ACHIEVEMENTS – 2020-21

Sustainable agriculture with organic practice by Tribal Farmers



MAJOR INTERVENTIONS

1100 tribal farmers from 46 villages from Rayagada & R.Udayagiri Block have cultivated vegetable like Brinjal, cauliflower, tomato, radish, beans, chilli, ridged gourd, bitter gourd and pumpkin in 447.61 acres of land. Farmers are using compost & organic fertilizer, organic pesticide adopting sustainable practices supported by MISEREOR, Germany.



384 Farmers have taken up organic Line Transplantation in Paddy 224.00 acres of land.



1513 farmers have adopted organic practices like preparation of handikhata, jebamruta, ambrutapani, hadari, pranamurta, peja tonic.

Food and Nutrition security including assured income source by the tribal farmers of Gumma Block Gajapati through sustainable and organic practice of Millets with support of Odisha Millet Mission through Agriculture Deptt., ATMA and Technical support of WASSAN

Since last three years CCD has been successfully implementing the Odisha Millets Mission with support of District Agriculture Department / ATMA with technical guidance of WASSAN to strengthen and orient the tribal families to adopt the sustainable practices with the new technology of SMI & CTI and organic inputs of Jevamutra, Handikhata to enhance the quality and quantity of different varieties of Millets. This project gave rebirth of Millet cultivation, family consumption and secured livelihood / income sources to the tribal farmers.

With the support of Odisha Millet Mission, CCD has promoted Ujayalla Farmers Producers Company in Gumma Block with shareholders of 145 members and financial transaction of INR 237000 during the reporting period. In the last year (2019-20) the shareholders were 16 only and the financial transactions was INR 50000. The Ujayalla FPO has adopted the business of Tamarind, Paddy and Seed and supplied through Community Seed Centre.

Major Achievements for sustainable livelihood intervention

The households annual incomes of the target group have increased by 41%

Cultivation of Paddy, Pulses, Millets, vegetables and other agricultural crops is increased by 60% Mortality of livestock has decreased by 80% because of the support of project staff and active cooperation of Veterinary department.







Promoted 3 nos of producers groups namely Dhanalaxmi, Laxminarayana and Godabari consisting of 87 members from the women SHGs and the tribal farmers. 100% of producer group members have engaged in business activities. They have initiated collective procuring and marketing of Ragi, Vegetables and Non-Timber forest produces at local haat and Ragi selling at MANDI point which is functioning by Rayagada and R.Udayagiri MANDI point. Each member is getting Rs. 1500/- as net profit as an average. From Ragi the member is getting Rs. 3200/- per qtl from MANDI as per MSP.









Odisha Millets Mission gives hope in reducing drudgery of women in postharvesting.

Traditional post –harvesting operations of millets women were facing difficulties due to small grain in size and threshing on the ground. In this traditional process of harvesting there is possibility of sand and pebbles getting mixed with the grains. After harvesting women have to dry it under sun rays and start threshing with the help of sticks to separate grains from the straw. Again they use "KUTUNI"to de husk the millets. to reduce the women drudgery **Odisha Millets Mission** has supplied four nos of thresher cum parler to Ujayalla Farmers Producer Company ltd. and they have demonstrated at village S.Kolakote, B.Kolakote & S.Kulunda under B.Kolakote & Tarangada GP on experiment basis. Women farmers are happy after using the thresher and "express their views that this has reduced the drudgery and saves productive time". It helps to increase the household level of consumption & sell their ragi to TDCC with a minimum support price without further processing


Focused Area Development Programme (FADP)

Centre for Community Development (CCD) in collaboration with Integrated Tribal Development Agency (ITDA), through FADP Project is working in 5 tribal sub-plan blocks (Gumma, Rayagada, Nuagada, R.Udayagiri & Mohona Blocks) of Gajapati District focusing and implementing different livelihood programmes with sustainable agriculture practices providing certified seed for vegetable cultivation, organic fertilizer, diesel motor pump sets, chick rearing, fish farming, mini rice huller to women SHGs apart from plantation like cashew, mango, litchi throgh mobilizing under MGNREGA.

WOMEN EMPOWERMENT AND PROMOTION OF MICRO ENTERPRISES

Mahendragiri Women Cooperative Sociey Itd

Mahendragiri Women Cooperative Society Ltd promoted by CCD at Mandalsahi of Rayagada Block of Gajapati to strengthen the rural economy through savings, credit and micro-enterprises promotion with the handholding support of project staff.

1331 women farmers of 104 SHGs are its members. The turnover of the cooperative is Rs.25.90 lakhs and it has been increased by 16% from the last year.



<u>During the year the following services</u> <u>have been provided</u>

- Loan amount of Rs 485000/- has been given to 28 members for undertaking income generation programme from the Cooperative.
- Members have repaid Rs 445268/- of the previous loan during the reporting period. Amount of Rs 15,58,277/- (cumulative loan amount) is outstanding with 110 members.
- Savings of Rupees 7,62,455/- has been raised from members. .
- Monthly report is being submitted to Assistant Register of Cooperative Society of Government of Odisha.
- ARCC has visited the office and inspected the books and records gave an inspection and stock verification report of Mahendragiri Women Cooperative Society

Gajapati Women Cooperative Society Ltd.

Gajapati Women Cooperative Society Ltd - a District level Federation of Women consisting of 649 Women Self-Help Groups in 5 Blocks of Gajapati District has been promoted by Centre for Community Development (CCD). The GWCSL is facilitating savings and credit management for its shareholders to strengthen income generation activities and encourage the women for self-reliant. The major income generation activities are:

753 meetings were conducted at SHG level to orient the members on DASA SUTRA (Ten formulas) prepared by OLM. Staff are facilitating to prepare for business development Gram Panchayat Level Federation Fund (GPLF) fund.

Vocational / Skill Development training to Women on value addition of millets

Trainigs on value addition of millets was provided to women SHG members to encourage them to regular household consumption especially by the pregnant, lactating and infants to improve nutrition potential as well as enhance the income through vaue added items. During the training the tribal women have prepared the following items from Ragi and other Millets.





Direct support of Rs. 12,000/- (MISEREOR-KZE project support of Rs. 7,500/- and beneficiary contribution of Rs. 4,500/-) has been provided to 10 poorest of the poor households identified by village development committee of respective villages for purchase of goats. The project team also supported them to start other income generation activities like kitchen garden etc.

MAINSTREAMING AND ECONOMIC REHABILITION OF PERSONS WITH DISABILITIES

CCD is emphasizing on socio-economic inclusion of Persons with Disabilities to mainstream them in the society with CBR approach. CCD is working with 3015 PwD members in Gajapati and promoted total 284 SHGs - this year 35 SHGs (5 - 7 members in each group), 6 block level DPOs and one District level DPO - SAMARTH. To capacitate and organize them, CCD is educating them on their rights and entitlements, various social security schemes of government and SDG. CCD has been always prioritizing on skill development of PwD members through different vocational trainings and encouraging them to promote micro enterprises for income generation activities.

Major interventions during the year 2020-2021

Four nos of sensitization trainings has organized. Mr. Niranjan Behera, Chairperson, SAMARTH cum President of State level DPO network and Mr. Santosh Kumar Moharana, Secretary, SAMARTH has facilitated as resource personal. The DPO members were oriented on their Rights and Entitlements, SDG, RPwD Act, 2016, 21 types of disabilities including personnal protection measures against CORONA pandemic.

- Major focus has laid on engagement of all DPO members for MGNREGA a per the guideline in engaging the DPO members irrespective of their Disabilities. Around 102 persons have placed their demands for work and 29 members got their muster roll ensuring their livelihood during Corona pandemic lockdown and shutdown.
- 9 village meetings and SHG meetings have been organized to sensitize on social distancing, face mask wearing, regular hand wash, use of hand sanitizer and stay safe.

Visit to micro enterprises running by Persons with Disability members

During the COVID situation the micro enterprises have been closed due to lockdown and shutdown by the Government. The PwD members have suffered a lot without income and somewhere very low income. In this situation Mr. A.Jagannadha Raju, Secretary, CCD and Mr. A.Padma Raj, Project Coordinator have visited the micro enterprises and interacted with them regarding their livelihood situation and other difficulties. During the visit the PwD members have shared their reality of life and hurdles faced during COVID. They have also shared about their access of different government emergency supports.



Some has expressed that they are getting Rs. 50/- per day in comparison to Rs.500/- per day before March'20. CCD encouraged them to maintain their self confidene.

- Mr.Manoj kumar Sahu of Adarsha nagar, Badigam, Kasinagar block was denied of admission in inter science. With continuous lobby by SAMARTH finally he got admission in inter-science.
- During the year 463 new PwD members have been identified from Nuagada, Gumma and Mohona blocks of Gajapati out of which 175 are female and 288 are male.
- 445 persons have received medical certificate
- 336 persons have engaged in livelihood activities.
- SAMARTH has celebrated Louis Braille Birthday and World Disabled Day at its office premises.

VISIT OF Mrs. SULOCHANA DAS, STATE COMMISSIONER FOR PERSONS WITH DISABILITIES ON 26th FEBRUARY, 2021

Mrs. Sulochana Das, State Commissioner for Persons with Disabilities along with Mrs. Kalyani Das, DSSO, Gajapati have visited CCD and SAMARTH-District level Disable Peoples Organization on 26th Feb'2021. A meeting was organized at CCD office premises with the congregation of 60 persons with disabilities - SAMARTH members from different blocks of Gajapati.

Mrs. Sulochana Das has oriented on the RPwD Act and focussed on how to access the government schemes. 30 PwD members have made grievances before the Commissioner regarding lack of ration cards, non-availability of DRI loan, not getting the medical certificate for hearing impaired persons (Deaf & Dumb) because of no doctor at District Headquarter Hospital, Gajapati. The SAMARTH personnel have placed a memorandum with 9 demands to the Commissioner in presence of DSSO, Gajapati.

Commissioner along with DSSO has distributed one Clutch to Mr. Madan Karjee of Rayagada block and three Tri-Cycles to Ms. Bh. Ejraavani Bhuyan of Rangalbadu, Mr Ejra Raito of Endri and Mr Dukan Naika of Endri. The Commissioner and DSSO have visited Jute bag unit at Paralakhemundi established by SAMARTH and Physiotherapy unit supported by SSEPD.

CASE STUDY OF PERSON WITH DISABILITY

Name of the Beneficiary : Mr. Pradip Dalei

Profession of the Beneficiary : Tailoring and Mushroom Cultivation Family Details : Father, Mother, Elder Sister, Three sons,

wife with total 8 members family

Profession of the family : Daily labour Nature of the Disability : Locomotor

Challenges

Pradip Dalai's father is a daily labour. His elder sister is maintaining a small petty shop and with the short income their 8 members family was getting food for one time. Pradip is getting monthly pension of Rs.500/-. Being a locomotor disability he has decided to start a tailoring unit in his house and his wife also supporting him. His wife is a SHG members in women group and Pradip is also a member of PwD group.

CCD and SAMARTH staff have visited and oriented them to mobilize support services from OLM for supply of dress for school children. CCD has also supported Rs. 20000/- to promote the tailoring unit and started liaisoning with OLM for supply the school dresses. They have supplied around 4000 face masks during corona with the support of OLM and CCD has also procured 500 masks from them. Apart from this his wife also motivated to get mushroom training from horticulture department.



Pradip and his wife both have started mushroom production unit and procured mushroom seed, polythylene and other required materials from horticulture deptt. and paddy straw for composting. Now with the low investment of Rs. 331/- for three beds he is getting Rs.800/- in 15 days. Now he is maintaining 30 beds and getting the income of Rs. 558/- per day. Horticulture department personnel have visited the unit and supported Rs. 10000/- as promotional amount.





THERAPEUTIC AND REHABILITATIVE SERVICES TO THE CHILDREN WITH INTELLECTUAL DISABILITY

Social Security and Empowerment of Persons with Disabilities Department (SSEPD), Government of Odisha has supported the Therapeutic & Rehabilitative services for 25 children with intellectual disabilities but CCD has extended the services for 56 children with disabilities in 6 Blocks of Gajapati whose details are with organization i.e., with Sl.No, Name of the Beneficiaries, Adhar Card, Age, Gender, Disability Certificate, Name of the Parents and contact number. CCD is focusing on their rehabilitation through physiotherapy exercise, training to the parents on therapy techniques and also providing financial assistance to their parents to enhance their income generation activities. Therapy is being done at cluster points for 10 - 15 children with intellectual disabilities and the physiotherapist is visiting 3 - 4 days in a month providing better services which is creating positive hope and confidence among the parents.

Amar karji, aged about 05yr is only son of Trinath karji of Rayagada. At the time of birth Amar was healthy but at the age of 2 years he was observed the symptom of cerebral palsy and he can't walk and unable to stand properly. His parents have made necessary arrangement for his treatment at government and private hospital. But there was no progress.

He was identified by CCD with the project support of SSEPD and started physiotherapy exercises four times in a month by our physiotherapist. During exercises, the parents are also being oriented on the procedures of exercises. The parents have continued daily exercises two times a day. Our physiotherapist has used instruments and machine-like walker, smile ball, acupressure ball U/S and IFT machine and some manual exercises like ADL training, Gait, Balance. Gradually Amar has started walking slowly with the supports of walker and the support of his parents.





A Brief Report on COVID management and Relief Services

Sensitization to the target community during CORONA pandemic period

From April'20 onwards the pandemic created the panic situation and due to its rapid transmission, the community are living in gloomy situation without any income source. The target community have engaged in limited agriculture work. The project staffs are motivating them that health is wealth and sensitized on personal protection measures in support and collaboration of PRI members, AWW, ASHA and village volunteers.



Social awareness on:

- Hand wash with soap and its importance
- Use of face mask, Avoid handshake, Keep Social distancing of minimum 3ft
- Take vitamin food/ fruit juice like Dal, Green vegetables, Papaya, lemon Mango etc. to improve immunity power.

With the support of MISEREOR/KZE, CCD has selected 500 vulnerable communities as identified by the villagers at village meetings.



- Promotion of Millet with sustainable agriculture practices with value addition from millet so that nutritious food consumption would be increased among the tribal community especially women and children.


Conclusion:
